Project Authorization Terms and Conditions

1. The Tenant and Contractor shall comply with all federal, state, local laws, statutes, and regulations as may be legally applicable to the work being performed.
2. The Tenant and Contractor shall protect the lives and health of the public and comply with all safety standards required by law and any additional standards customarily employed in connection with the type of work being performed or the conditions at the site.
3. The Tenant must maintain on file with CCIA certificates of insurance evidencing all required coverage and special provisions. It is the responsibility of the Tenant to require and verify Tenant's contractor has adequate insurance coverage equal or exceed that of lease agreement.
4. The Tenant must maintain at the work site a minimum of the following: CCIA Tenant Modification approved application, plans, specifications, and all applicable City Permits.
5. The Tenant must share construction drawings and project schedule.
6. The Tenant and Contractor must share copies of SDS (Safety Data Sheets) for all chemicals which will be used for the project.
7. The Tenant must share Contractor & subcontractor contact information if any are used for project. It is the responsibility of the Tenant to update the point of contacts with CCIA if they change.
8. The Tenant and Contractor must only work on area (any part of building, structure, etc.) for which authorization was granted.
9. CCIA Director or appointee may conduct project walk-throughs and inspections at their discretion and as needed throughout the length of the project.
